1. NO PURCHASE NECESSARY to enter. All entries must be mailed directly to: UTI Foundation, 20410 North 19<sup>th</sup> Ave., Suite 200, Phoenix, AZ 85027. Entries will be judged based on originality of content (25%), creativity of presentation (25%) and demonstrated enthusiasm of applicant for a career as an automotive technician (50%).
2. All entries must be postmarked by March 12, 2010 to be eligible. There is a limit of one entry per person per contest year. Multiple entries by the same person will cause all entries by that person to become ineligible. Not responsible for late, lost or misdirected mail. The scholarship winner will be announced at the USHRA Monster Jam World Finals at Sam Boyd Stadium, Las Vegas NV. Funding for this scholarship is provided by Feld Entertainment.
3. The winner will be chosen by Dennis Anderson or his representative, will be notified by first class mail, and will be required to sign an affidavit of eligibility and release. Except where prohibited, the winner's name and likeness may be used for publicity purposes for this or similar promotions without additional compensation. There may be no substitution of scholarship, nor is the scholarship transferable. Winner may waive his or her right to receive the scholarship prize.
4. All applicable taxes on the scholarship and any other associated costs are the sole responsibility of the scholarship winner.
5. The scholarship claim is subject to the verification of eligibility prior to awarding by the UTI Foundation. Materials submitted will become the property of the UTI Foundation, and will not be returned. The recipient will be required to sign, have notarized and return the Affidavit of Eligibility within 30 days or scholarship will be forfeited. Entrants must also release any applicable forms required by tax authorities.
6. Applicants release the UTI Foundation, Universal Technical Institute, Inc and Dennis Anderson/Feld Entertainment, and their employees, promotion suppliers and advertising and promotion agencies from any and all liability with respect to the scholarship and acknowledges that said parties have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, expressed or implied, in fact or in law, relative to the scholarship, including, but not limited to, its quality or fitness for a particular purpose.

Class dates and times may be changed at the discretion of UTI. 8. All residents of the United States, who are licensed drivers and are 18 years of age or older, and who possess a high school diploma or the equivalent, or who have received a passing grade on the Wonderlic Test are eligible, except for current or past Universal Technical Institute, Inc employees and members of their immediate families. Promotion is void where prohibited, taxed or otherwise restricted by law.
