

## **UTI Race School Experience Sweepstakes Official Rules**

**NO PURCHASE NECESSARY OR ENROLLMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.**

**DATES OF PROMOTION:** The UTI Race School Experience Sweepstakes begins at 12:00 a.m. Eastern Time ("ET") on April 10, 2009 and ends at 11:59 p.m. ET on December 31, 2009. All entrants must have access to the Internet in order to participate in this Sweepstakes. Normal Internet, phone and usage charges imposed by your online or phone service may apply.
